PART II

GUIDE ON HOW TO USE PAIA AND HOW TO OBTAIN ACCESS TO THE GUIDE

- 1.1 The Information Regulator has, in terms of section 10(1) of PAIA, as amended, updated and made available a Guide on how to use PAIA ("Guide"), in an easily comprehensible form and manner, as may reasonably be required by a person who wishes to exercise any right contemplated in PAIA and POPIA.
- 1.2 The Guide is available in each of the official languages and in braille.
- 1.3 The aforesaid Guide contains the description of-
 - 1.3.1 the objects of PAIA and POPIA;
 - 1.3.2 the postal and street address, phone and fax number and, if available, electronic mail address of-
 - 1.3.2.1 the Information Officer of every public body, and
 - 1.3.2.2 every Deputy Information Officer of every public and private body designated in terms of section 17(1) of PAIA and section 56 of POPIA;
 - 1.3.3 the manner and form of a request for-
 - 1.3.3.1 access to a record of a public body contemplated in section 11 of PAIA; and
 - 1.3.3.2 access to a record of a private body contemplated in section 50 of PAIA;
 - 1.3.4 the assistance available from the IO of a public body in terms of PAIA and POPIA;
 - 1.3.5 the assistance available from the Regulator in terms of PAIA and POPIA;
 - 1.3.6 all remedies in law available regarding an act or failure to act in respect of a right or duty conferred or imposed by PAIA and POPIA, including the manner of lodging-
 - 1.3.6.1 an internal appeal;

- 1.3.6.2 a complaint to the Regulator; and
- 1.3.6.3 an application with a court against a decision by the information officer of a public body, a decision on internal appeal or a decision by the Regulator or a decision of the head of a private body;
- 1.3.7 the provisions of sections 14 and 51 of PAIA requiring a public body and private body, respectively, to compile a manual, and how to obtain access to a manual;
- 1.3.8 the provisions of sections 15 and 52 of PAIA providing for the voluntary disclosure of categories of records by a public body and private body, respectively;
- 1.3.9 the notices issued in terms of sections 22 and 54 of PAIA regarding fees to be paid in relation to requests for access; and
- 1.3.10 the regulations made in terms of section 92 of PAIA.
- 1.4 Members of the public can inspect or make copies of the Guide from the offices of the public and private bodies, including the office of the Regulator, during normal working hours.
- 1.5 The Guide can also be obtained-
 - 1.5.1 upon request to the Information Officer;
 - 1.5.2 from the website of the Regulator (<https://www.justice.gov.za/inforeg/>).
- 1.6 A copy of the Guide is also available in the following three official languages, for public inspection during normal office hours-

 - 1.6.2 Afrikaans;
 - 1.6.3 isiZulu and
 - 1.6.4 isiXhosa

PART III

GROUND FOR REFUSAL OF ACCESS TO RECORDS

The main grounds for the Private Body to refuse a request for information relates to the -

- 1.7 mandatory protection of the privacy of a third party who is a natural person, which would involve the unreasonable disclosure of personal information of that natural person;
- 1.8 mandatory protection of the commercial information of a third party, if the record contains –
 - 1.8.1 trade secrets or any other such intellectual property of that third party;
 - 1.8.2 financial, commercial, scientific or technical information which disclosure could likely cause harm to the financial or commercial interests of that third party;
 - 1.8.3 information disclosed in confidence by a third party to the Private Body, if the disclosure could put that third party at a disadvantage in present or future negotiations and/or commercial competition;
- 1.9 mandatory protection of confidential information of third parties if it is protected in terms of any agreement or legislation;
- 1.10 mandatory protection of the safety of individuals and the protection of property;
- 1.11 mandatory protection of records which would be regarded as privileged in legal proceedings;
- 1.12 the commercial activities of the Private Body, which may include –
 - 1.12.1 trade secrets or any other such intellectual property of the Private Body;
 - 1.12.2 financial, commercial, scientific or technical information which disclosure could likely cause harm to the financial or commercial interests of the Private Body;
 - 1.12.3 information which, if disclosed could put the Private Body at a disadvantage in present or future negotiations and/or commercial competition;
 - 1.12.4 a computer program which is owned by the Private Body, and which is protected by copyright.
- 1.13 the research information of the Private Body or a third party, if its disclosure would disclose the identity of the Private Body, the researcher or the subject matter of the research and would place the research at a disadvantage;
- 1.14 Requests for information that are clearly frivolous or vexatious, or which involve an unreasonable diversion of resources shall be refused.

REMEDIES AVAILABLE WHEN A PRIVATE BODY REFUSES A REQUEST FOR INFORMATION

1.15 INTERNAL REMEDIES

The Private Body does not have an internal appeal procedure. As such, the decision made by the information officer is final, and requesters will have to exercise such external remedies at their disposal if the request for information is refused, and the requester is not satisfied with the answer supplied by the information officer.

1.16 EXTERNAL REMEDIES

A requester that is dissatisfied with an information officer's refusal to disclose information may, within 180 days of notification of the decision, lodge a complaint with the Information regulator on the prescribed form which can be found at <https://www.justice.gov.za/infoereg/docs.html> or apply to the relevant Court for relief

A third party dissatisfied with an information officer's decision not to grant a request for information, may within 180 days of notification of the decision, lodge a complaint with the Information regulator on the prescribed form which can be found at <https://www.justice.gov.za/infoereg/docs.html> or apply to a Court for relief. For purposes of the Act, the Courts that have jurisdiction over these applications are the Constitutional Court, the High Court or any other court with similar status.

REQUEST PROCEDURE

1.17 The requester must comply with all the procedural requirements contained in the Act relating to the request for access to a record.

1.18 The requester must complete the prescribed form enclosed herewith in **Appendix 1**, and submit same as well as payment of a request fee and a deposit, if applicable to the Information Officer at the postal or physical address, fax number or electronic mail address as stated in 2.1 or 2.2 above.

1.19 The prescribed form must be filled in with enough particularity to at least enable the Information Officer to identify –

1.19.1 The record or records requested;

1.19.2 The identity of the requester,

1.19.3 Which form of access is required, if the request is granted;

1.19.4 The postal address or fax number of the requester.

1.20 The requester must state that he/she requires the information in order to exercise or protect a right, and clearly state what the nature of the right is so to be exercised or protected. In addition, the requester must clearly specify why the record is necessary to exercise or protect such a right.

1.21 The Private Body will process the request within 30 days, unless the requester has stated special reasons which would satisfy the Information officer that circumstances dictate that the above time periods not be complied with.

1.22 The requester shall be informed whether access granted or denied. If, in addition, the requester requires the reasons for the decision in any other manner, he/she must state the manner and the particulars so required.

- 1.23 If a request is made on behalf of another person, then the requester must submit proof of the capacity in which the requester is making the request to the reasonable satisfaction of the information officer.
- 1.24 If an individual is unable to complete the prescribed form because of illiteracy or disability, such a person may make the request orally.
- 1.25 The requester must pay the prescribed fee, before any further processing can take place.

ACCESS TO RECORDS HELD BY THE PRIVATE BODY

- 1.26 Records held by the Private Body may be accessed by requests only once the prerequisite requirements for access have been met.
- 1.27 A requester is any person making a request for access to a record of the Private Body. There are two types of requesters:

1.28 PERSONAL REQUESTER

- 1.30.1.1 A personal requester is a requester who is seeking access to a record containing personal information about the requester.
- 1.30.1.2 The Private Body will voluntarily provide the requested information or give access to any record with regard to the requester's personal information. The prescribed fee for reproduction of the information requested will be charged.

1.30.2 OTHER REQUESTER

- 1.30.2.1 This requester (other than a personal requester) is entitled to request access to information on third parties. However, the Private Body is not obliged to voluntarily grant access. The requester must fulfil the prerequisite requirements for access in terms of the Act, including the payment of a request and access fee.

FEES

- 1.29 The Act provides for two types of fees, namely:
 - 1.29.1 A request fee, which will be a standard fee; and
 - 1.29.2 An access fee, which must be calculated by taking into account reproduction costs, search and preparation time and cost, as well as postal costs.
- 1.30 When the request is received by the Information Officer, such officer shall by notice require the requester, other than a personal requester, to pay the prescribed request fee (if any), before any further processing of the request.
- 1.31 If the search for the record has been made and the preparation of the record for disclosure, including arrangement to make it available in the requested form, requires more than the hours prescribed in the regulations for this purpose, the information officer shall notify the requester to pay as a deposit the prescribed portion of the Access fee which would be payable if the request is granted.

- 1.32 The information officer shall withhold a record until the requester has paid the fees as indicated in **Appendix 2**.
- 1.33 A requester whose request for access to a record has been granted, must pay an access fee for reproduction and for search and preparation, and for any time reasonably required in excess of the prescribed hours to search for and prepare the record for disclosure including making arrangements to make it available in the request form.
- 1.34 If a deposit has been paid in respect of a request for access, which is refused, then the information officer concerned must repay the deposit to the requester.

DECISION

- 1.35 The Private Body will, within 30 days of receipt of the request, decide whether to grant or decline the request and give notice with reasons (if required) to that effect.
- 1.36 The 30 day period with which the Private Body has to decide whether to grant or refuse the request, may be extended for a further period of not more than thirty days if the request is for a large amount of information, or the request requires a search for information held at another office of the Private Body and the information cannot reasonably be obtained within the original 30 day period. The Private Body will notify the requester in writing should an extension be sought

PROCESSING OF PERSONAL INFORMATION

- 1.37 Purpose of Processing Personal Information:
- 1.37.1 to verify your identity;
- 1.37.2 to comply with –
- 1.39.2.1. any obligations imposed by law; or
- 1.39.2.2. orders, directions or requests from any court, authority or government body;
- 1.39.3. for marketing (including direct marketing as contemplated in the Act), promotional and customer relationship management purposes. Should you not want to receive these specific communications you can decline by clicking [here](#) emailing aquarium@aquarium.co.za or unsubscribing via our e-mail communication at any time;
- 1.39.4. for conducting market research;
- 1.39.5. to contact you regarding any competitions you have entered;
- 1.39.6. to pursue any other legitimate interest of the Organisation.

1.39 **General description of Information Security Measures to be implemented by the responsible party to ensure the confidentiality, integrity and availability of the information**

1.41.1. password changes are in line with industry good practice are enforced and guidance shall be given to its Employees on password strength;

1.41.2. dual factor authentication shall be used for remote access to connect to the Organisation's network from a remote location, through the use of a password and physical token;

1.41.3. all systems have inbuilt access virus and malware scanning and that systems are checked daily for updates to antivirus signatures;

1.41.4 all virus infections shall be logged to a central management server and that a virus response process shall be in place to ensure that infections are dealt with appropriately;

1.41.5 the use of a multi-layered firewall design shall be in place to protect its internal network systems, that firewall logs shall be monitored for anomalies and that identified anomalies shall be addressed;

- 1.41.6 it takes regular back-ups of Personal Information on its network systems and keep such back-ups in a secure facility;
- 1.41.7. access to its servers via privileged administration accounts shall be strictly limited and audited and that access to servers shall be based on the minimum access rights required;
- 1.41.8 its servers shall be secured within data centres by implementing adequate physical security measures and ensuring availability;
- 1.41.9 it employs secure screen savers;
- 1.41.10 electronic storage media (eg. external hard drive, flash drive, CD, DVD) which no longer needs to be retained is handed to the Organisation's IT department so that it can be disposed of through a secure destruction process whereby the information stored on the media can no longer be retrievable.

APPENDIX – 2

PRESCRIBED FEES

Request fees:

Where a requester submits a request for access to information held by a Private Body on a person other than the requester himself/herself, a request fee in the amount of R140,00 is payable up-front and, in addition to the request fee, an access fee for search and preparation of the record (if applicable) may apply.

Reproduction Fees

Where the Private Body has voluntarily provided the Minister with a list of categories of records that will automatically be made available to any person requesting access thereto, the only charge that may be levied for obtaining such records, will be a fee for reproduction of the record in question.

Access fees:

An access fee is payable in all instances where a request for access to information is granted, except in those instances where payment of an access fee is specially excluded in terms of the Act or an exclusion is determined by the Minister in terms of Section 54 (8).

Deposits:

Where the Private Body receives a request for access to information held on a person other than the requester himself/herself and the information officer upon receipt of the request is of the opinion that the preparation of the required record of disclosure will take more than 6 (six) hours, a deposit is payable by the requester.

The amount of the deposit is equal to $\frac{1}{3}$ (one third) of the amount of the applicable access fee.

Note: In terms of Regulation 8, Value Added Tax (VAT) must be added to all fees prescribed in terms of the Regulations.
